SEEKING CANDIDATES

The Libertarian Party of Arkansas (LPAR) is seeking candidates to run for office in 2022. We welcome all freedom-minded individuals who want to make a difference. The following pages provide a step-by-step guide to be a Libertarian candidate for public office in 2022.

As a "new political party," Arkansas election law requires that the party nominate its candidates by convention for the first general election following certification [Ark. Code Ann. § 7-7-102(b)]. For the Libertarian Party of Arkansas in 2022, this means that all candidates for public office, on every level, will be chosen at a state convention to be held in Little Rock on February 18-20, 2022. Candidates will be required to file during the party filing period from February 22-March 1, 2022.

REQUIREMENTS TO RUN FOR OFFICE

01 BE A US CITIZEN FOR THE LENGTH OF TIME REQUIRED FOR THE OFFICE (RANGES FROM 0-9 YEARS).

- **02** BE ELIGIBLE TO VOTE.
- **03** BE REGISTERED TO VOTE.
- **14.** BE OF LEGAL AGE TO HOLD THE OFFICE (RANGES FROM 18 TO 30).
- **05** BE AN ARKANSAS RESIDENT FOR THE LENGTH OF TIME REQUIRED FOR THE OFFICE (RANGES FROM 0 TO 7 YEARS).
- **O6** BE A RESIDENT IN THE DISTRICT FOR THE LENGTH OF TIME REQUIRED FOR THE OFFICE (RANGES FROM 0-1 YEAR FROM DATE OF GENERAL ELECTION).
- **07** MUST NOT HOLD ANY OTHER FEDERAL, STATE, OR CIVIL OFFICE (YOU CANNOT HOLD TWO OFFICES AT THE SAME TIME.)
- **O8** MUST NEVER HAVE BEEN CONVICTED OF EMBEZZLEMENT OF PUBLIC MONEY, BRIBERY, FORGERY, OR OTHER INFAMOUS CRIME.
- **Ug** must not be a convicted felon. *

10 MUST NOT BE PAST YOUR TERM LIMIT IN THAT OFFICE.

THESE REQUIREMENTS ARE DETAILED ON PAGES 10-18 OF THE RUNNING FOR OFFICE HANDBOOK PUBLISHED BY THE ARKANSAS SECRETARY OF STATE.

*A prospective candidate for state, district, county, municipal, or township office who has had a felony conviction expunged in accordance with Ark. Code Ann. Section 16-93-301-303 or similar expunction statute in another state may certify that he or she has never been convicted of a felony, provided the candidate presents a certificate of expunction from the court that convicted the prospective candidate. See Ark. Code Ann. Section 7-6-102(d).

FILING FEES

US CONGRESS, US SENATE, GOVERNOR	\$250
STATE LEGISLATURE, STATE OFFICER (EXCEPT GOVERNOR)	\$100
COUNTY, LOCAL, TOWNSHIP OFFICES	\$25

Note that filing fees are paid to the LPAR and will be used for party-building and candidate promotion during the campaign season. Filing fees are non-refundable, but may be "rolled down" to pay the fee for another office. This means if you do not receive the nomination you want but decide to run for a lower-level office, you will not need to pay multiple filing fees.

TYPES OF CAMPAIGNS

"CHOICE" CANDIDATE

A "choice candidate serves as a placeholder who agrees to sign the paperwork and add his or her name to the ballot, but does not actively campaign. Choice candidates play a vital role in our electoral strategy. They add numbers to our vote totals while giving all voters, not just members of our party, a choice to vote for a Libertarian on Election Day. Many placeholder candidates also fill out candidate surveys to let the voters know about our positions on various issues. These campaigns cost very little and take very little time to run.

"CHANGE" CANDIDATE

A "change" candidate is one step beyond a "choice" candidate, playing more of an educational role. Change candidates appear at candidate debates/forums and provide Libertarian answers to any questionnaires they may receive. They may also produce a website, brochures, or business cards. This is your chance to advocate for change and to hold an elected official accountable in a public arena! A great change campaign can be run for less than \$500.

"CHALLENGE" CANDIDATE

A "challenge" candidate runs an active campaign with the intent of winning the election and challenging the status quo. Running this type of race requires a statistical chance of winning along with fierce dedication and a commitment to campaigning, fundraising, and educating voters. Nominated candidates who pursue this active level of campaigning will receive the most active support for their campaign that the LPAR can offer.

ADDITIONAL INFORMATION ON TYPES OF CAMPAIGNS

• If this is your first political campaign, running as a "choice" candidate might be the most comfortable level of activity as you develop campaign skills.

• Potential "change" and "challenge" candidates should pay careful attention to the candidate campaign criteria worksheets for a better idea

of expectations for those types of campaigns.

• "Challenge" candidates are expected to run, to the very best of their ability, a professional campaign that promotes the LPAR and our principles in a manner that brings respect to the party.

PAPERWORK: A STEP BY STEP GUIDE



TO BECOME AN OFFICIAL CANDIDATE OF THE LIBERTARIANS PARTY OF ARKANSAS, YOU WILL NEED TO BE NOMINATED BY OUR MEMBERSHIP AT THE STATE NOMINATING CONVENTION, FEBRUARY 18-20, 2022. TO SUCCESS-FULLY PUT YOUR NAME FORWARD AT THE CONVENTION, YOU ARE ENCOUR-AGED TO FOLLOW THESE STEPS:

O2 COMPLETE AND SUBMIT THE RUN FOR OFFICE FORM ON THE LIBERTARIAN PARTY WEBSITE: <u>https://my.lp.org/run-for-office/</u>

O3 COMPLETE THE QUESTIONNAIRE INCLUDED IN THIS HANDBOOK. YOU MAY COMPLETE IT ELECTRONICALLY AND SUBMIT IT TO ELECTIONS@LPAR.ORG, OR YOU MAY PRINT, COMPLETE, AND SUBMIT IT TO: LPAR ELECTIONS COMMITTEE, PO BOX 46730, LITTLE ROCK, AR 72214. THIS INFORMATION WILL BE INCLUDED IN OUR CONVENTION HANDBOOK SO THAT DELEGATES WILL KNOW MORE ABOUT YOU BEFORE THEY CAST THEIR VOTE AT CONVENTION. PLEASE NOTE THAT WHILE. COMPLETION OF THE QUESTIONNAIRE IS NOT REQUIRED FOR NOMINATION, FAILURE TO COMPLETE IT WILL DEPRIVE THE DELEGATES OF VITAL INFORMATION ABOUT YOUR BELIEFS AND POSITIONS, WHICH MAY IMPACT YOUR CHANCES OF NOMINATION NEGATIVELY AT THE CONVENTION.

04 PLAN TO ATTEND OUR NOMINATING CONVENTION SO WE CAN MEET YOU, VOTE ON YOUR NOMINATION, COMPLETE OTHER REQUIRED PAPERWORK, COLLECT YOUR FILING FEE, AND SHARE TRAINING RESOURCES WITH YOU. WE STRONGLY ENCOURAGE ALL CANDIDATES FOR NOMINATION TO PERSONALLY ATTEND THE CONVENTION. REGISTRATION AND OTHER INFORMATION CAN BE FOUND AT:

^{*}A prospective candidate for state, district, county, municipal, or township office who has had a felony conviction expunged in accordance with Ark. Code Ann. Section 16-93-301-303 or similar expunction statute in another state may certify that he or she has never been convicted of a felony, provided the candidate presents a certificate of expunction from the court that convicted the prospective candidate.

REPORTING

Candidates for Federal Office (US House, US Senate) must file with the Federal Elections Commission if their receipts or expenditures exceed \$5,000. A candidate guide is available at <u>https://www.fec.gov/help-candidates-and-committees/guides/</u>. Reporting forms are also available at the FEC website.

Candidates for State and Local Office must comply with the regulations of the Arkansas Ethics Commission. Financial reporting is required if receipts or expenditures exceed \$500. Candidates should consult the publication "Running for Public Office" from the Secretary of State's office: <u>https://www.sos.arkansas.gov/uploads/elections/2022_Running_for_Public_</u>

Please be aware that Arkansas now requires electronic filing for candidate finance and other reports. You are encouraged to familiarize yourself with this system. Please see: <u>https://www.sos.arkansas.gov/elections/financial-disclosure</u>.

Be aware that, as a candidate for state or local public office, you are required to submit personal financial disclosure forms in addition to campaign finance reports. The LPAR does not provide legal advice. You are responsible for your own campaign and financial reporting. However, the Arkansas Ethics Commission can answer questions by phone and provide educational material for candidates.

CANDIDATE RESPONSIBILITIES & PARTY SUPPORT

The Libertarian Party of Arkansas will make every effort to assist its candidates, but does not render legal services or legal advice. The Arkansas Ethics Commission (<u>http://arkansasethics.com</u>) and the Secretary of State's division of elections (<u>http://www.sos.</u> <u>arkansas.gov/elections/</u>) have attorneys on staff who can convey legal opinions.

A candidate seeking the nomination of the Libertarian Party of Arkansas is responsible for his/her own campaign. The LPAR will provide informational services and support, but candidates are responsible for their own fundraising and for campaign management. The LPAR may, at the discretion of the Executive Committee, direct funding toward specific campaigns.

Candidates are nominated with the general expectation that they are familiar and largely in agreement with the Libertarian platform. While candidates might not fully agree with every plank of the platform, emphasizing Libertarian principles and promoting Libertarian positions during campaigns should be a priority for Libertarian candidates. Because future ballot access depends on the electoral performance of our candidate for governor, the LPAR asks all candidates to support our nominee for governor. We also ask that our candidates do not publicly endorse candidates from other parties.
